

Safety instructions for transport operator.

The contractor's personnel shall comply with all applicable regulations and guidelines of CAMPINE/CAMPINE RECYCLING.



Prohibitions

Before the transport begins, the driver checks the condition of his or her vehicle and the load and takes the necessary action for safe road transport.

Every driver must report to the counter upon shipping and receipt before entering the CAMPINE/CAMPINE RECYCLING site himself or herself or with his or her truck. He or she can only be on the site if the necessary instructions and signals have been given to enter the site.

For deliveries of batteries and lead wastes, you can register between 6.30 a.m. and 4 p.m. For deliveries and shipments of other goods, this is between 7.30 a.m. and 3.30 p.m. The truck can no longer be unloaded or loaded later than this registration time. In that case, the driver must park on the side so as not to obstruct other road users.

On the site, the indicated speeds (15 km/h), instructions for waiting areas and loading points and route indications must be observed.

The driver always waits for the next instruction before preparing the truck for unloading/loading. During loading and unloading, the driver must remain with the vehicle so that he or she can take the necessary action in an emergency.

Under no circumstances may the driver enter the site or any building himself or herself. If the driver needs assistance, he or she must contact the loader or unloader or return to the weighbridge.

The regulations regarding protective equipment, which are indicated on the site, must be adhered to. Long trousers, long-sleeved jacket, safety shoes, reflective vest, hard hat and safety glasses are provided.

The driver only leaves the site after all freight has been properly secured and checked by the loader and after all formalities have been completed.

Prohibitions

Photo and film equipment must not be brought into CAMPINE/CAMPINE RECYCLING. The use of social media on the site or about the site is not permitted.

It is not permitted to smoke, eat or drink on the site.

The use of mobile phones while driving is explicitly prohibited.

Children are not allowed on the site.

General provisions

The carrier ensures that he or she is trained in accordance with the applicable regulations. He or she ensures that he or she does not take any shortcuts and sticks to the general traffic regulations.

Any damage caused by the carrier either to CAMPINE/CAMPINE RECYCLING internal buildings/installations or to goods to be transported must be reported immediately. This must not be postponed. With regard to damage to goods, a request must immediately be made of CAMPINE/CAMPINE RECYCLING as to how the damage to the products will be handled.

In the case of ADR transports, the operator ensures that he or she is sufficiently trained to transport the goods and to follow all aspects of the ADR regulations.

CAMPINE/CAMPINE RECYCLING always has the right to check the activities, to prohibit the use of unsafe material and/or working methods and stop the work. This can be imposed if CAMPINE/CAMPINE RECYCLING is convinced that the work being done or the way in which it is being done is dangerous or can present dangers afterwards.

The driver ensures that the load and/or his or her freight cannot be stolen/sabotaged and/or used for the transport of drugs/illegal goods and people. CAMPINE/CAMPINE RECYCLING is entitled to notify the police if there are serious doubts about this.

A deliberate derogation from the desired behaviour can lead to the driver being excluded.

If it cannot be done safely, we don't do it.
